## GENERAL INFORMATION

### Manufacturer's Suggested Retail Price (MSRP)

The MSRP suggested is retail price of the vehicle (including freight).

### How to Use this Guide to Calculate New Vehicle Residuals

1. Enter the MSRP of the vehicle to be leased.
2. Delete the MSRP of any equipment removed from vehicle as well as gas guzzler taxes.
3. Add the amount of any Dealer Installed Options (DIO) listed in Dealer Installed Options section below to the MSRP to calculate the residuals.
4. Reference the specific vehicle to be leased within the residual value tables on subsequent pages.
5. Determine the residual factor for the appropriate lease term for said vehicle.
6. Determine the appropriate residual increment for low or ultra-low mileage use, if applicable, per the Low Mileage Programs section below.
7. Determine any applicable residual decrements per Upfront Extra Mileage section below.
8. Determine the appropriate residual decrements for manual transmission (Manual Transmission section) and/or beginning mileage over 500 miles (Beginning Mileage section), if applicable.
9. Multiply the total residual factor (line 5 + line 6 – Line 7 – Line 8) by the total sum of lines 1 through 3 above.

### Gas-Guzzler Tax

Deduct the tax from vehicle's MSRP before calculating the Residual Value.

## ELIGIBILITY

### Customer Eligibility

Eligible customers include businesses and individuals with acceptable credit history, financial means and insurance coverage to support the payment terms.

### Ineligible Vehicles

1. Vehicles with special equipment
2. Driver's education vehicles
3. Emergency or law enforcement vehicles
4. Frame-damaged vehicles
5. Hail or flood damaged vehicles
6. Limousines
7. Compressed natural gas vehicles
8. Previously titled vehicles
9. Used vehicles or vehicles with more than 5,000 miles for non-demonstrator vehicles and 7,500 miles for demonstrator vehicles
10. Modified, customized or racing vehicles

12. Right-hand drive vehicles (i.e. postal delivery, etc.)

## MILEAGE

### Mileage

All residuals published in this guidebook are based on 15,000 miles per year. In cases where the anticipated usage is in excess of the standard miles per year (or beginning mileage exceeds 500 miles), the residual must be reduced at lease inception. To adjust a residual for excess mileage and/or starting miles, see the Upfront Extra Mileage section on page 4 and/or the Beginning Mileage section on page 3.

### Beginning Mileage

1. Non-Demonstrator Vehicles

For all vehicles - excluding demonstrators, previous high school education vehicles and special event vehicles - the mileage at lease inception cannot exceed 5,000 miles. If the beginning mileage exceeds 500, adjust the residual value down for all miles over 500 by \$0.20 per mile. (SRT®, Trackhawk, TRX, Wrangler 392, Wagoneer and Grand Wagoneer vehicles receive a \$0.40 per mile residual adjustment.) Lessees must contract for the standard mileage allowance (15,000 miles annually) to purchase extra mileage.

2. Demonstrator Vehicles

Beginning mileage cannot exceed 7,500 miles on previous demonstrator vehicles, previous high school driver education vehicles and special event vehicles. If the beginning mileage exceeds 500, adjust the residual value down for all miles over 500 by \$0.20 per mile. (SRT®, Trackhawk, TRX, Wrangler 392, Wagoneer and Grand Wagoneer vehicles receive a \$0.40 per mile residual adjustment.) Lessees must contract for the standard mileage allowance (15,000 miles annually) to purchase extra mileage.

## MILEAGE ABSORPTION

The Excessive Wear and Use section of the lease contract includes an option for a lessee to absorb the existing miles on the vehicle, when in excess of 500 miles, into the total allowable mileage. If this box in the section is checked, the vehicle was driven more than 500 miles before the beginning

of the lease. The lessee acknowledges, agrees to and understands that the total permissible miles on the odometer before they begin to incur excessive use charges at scheduled termination is the total of the annual miles for the lease term, which includes the miles already on the vehicle at lease execution. This option is not available for PHEV models.

### Upfront Extra Mileage

On vehicles where anticipated usage exceeds the standard 15,000 miles per year, the residual must be reduced at lease inception at the rates shown below:

\*Upfront extra mileage is not available on low or ultra-low mileage leases.

Maximum Mileage allowed is 80,000 miles; Maximum Annual Mileage allowed is 20,000 miles.

### Excess Mileage at Termination

The Standard Excess Mileage Charge at Lease Termination is \$0.25 per mile driven over total allowed miles, except for the SRT®, Trackhawk, TRX, Wrangler 392, Wagoneer and Grand Wagoneer vehicles where said charge is \$0.50 per mile.

### Low Mileage Programs

For tiers 1-3 only, residuals may be increased for low and ultra-low mileage leases as follows:

All Models	24 & 27 months	36, 39 & 42 months	48 months
Low (12,000/yr)	1	2	3
Ultra-Low (10,000/yr)	2	3	4

### Manual Transmission

For manual transmissions, generally deduct two points for models that offer both manual and automatic transmissions. However, there is no need to deduct two points for manual transmission on the following vehicles:

- FIAT® 500 trim descriptions ending in "manual"
- FIAT 500X trim descriptions ending in "manual"
- FIAT 124 Spider trim descriptions ending in "manual"

## OEM OPTIONS AND ACCESSORIES

### Minimum Residual Value

Vehicles with base residual values below 20% of the total MSRP, as well as vehicles with reduced residual values below 20% based on anticipated use and mileage, are not acceptable for lease.

**Dealer Options that Void Warranties**

Chrysler Capital will not lease vehicles with options that void a manufacturer's warranty. Warranties that extend beyond the term of the lease are not permitted.

**OEM Accessories**

Approved accessories include automotive equipment that is produced or approved by the Original Equipment Manufacturer (OEM).

**Dealer Installed Options**

Any DIO that does not adversely affect the future resale value of the vehicle can be capitalized on a lease deal. Multiple DIOs can be residualized up to a combined maximum of \$1,200 and must be within credit approval max guidelines. All approved DIO costs included in the MSRP for residual calculations must be substantiated by dealer repair orders with Mopar part numbers and invoices signed by the customer.
