Maximum Backend	Credit life and accident and disability insurance are available based on state guidelines
Vehicle Service Contract Eligibility	Vehicle service contract is eligible to be sold on contracted lease deals where the annual mileage (plus any upfront purchased mileage) multiplied by the term of the lease exceeds the manufacturer's standard warranty coverage. VSC cannot exceed max advance approved or exceed \$6,500.
