ELIGIBILITY:

- » Valid for all FCA US dealers
- » All qualified customers are eligible

- » New, CPO and used vehicles

ADDITIONAL DETAILS/ELIGIBILITY:

- » Retail contracts only
- » Maximum miles at contract initiation = 50,000
- » Compatible for standard and incentivized rate programs
- » Non-commercial and commercial transactions
- » Original upfit invoice must be included
 - Invoice of the upfit must be identified by VIN and payable to the dealership
- » If no bookout is available on a newer unit, refer to like invoice valuation guidelines located in the [Retail Program Guide](#) on the [Chrysler Capital Dealer Website](#)

ADVANCE GUIDELINES:

- » Refer to the [Chrysler Capital Commercial Rate Sheet](#) for advance guidelines
- » Commercial upfits are treated as a dealer installed option (DIO) that adds value; 100% of the upfit cost can be added to the manufacturer invoice price
- » We advance based on the cost of the vehicle, plus the cost of the upfit

Loan-to-Value Calculation* (\$40,000.00)
